- Continue our proud record of no lives lost during surf lifesaving patrols.
- Be highly regarded by the local community as a volunteer service provider.
- Foster and promote the ideals of healthy lifestyle to our members and the local community.

PRESIDENT'S REPORT

This season we have invested quite a lot of money into the club and its infrastructure. A lot of the items purchased were budgeted for, such as the signage, shade sails, car lift, tower (which was delayed due to manufacturing issues) and the additional solar panels. However, we did not budget for having to buy a new Lifesaving Patrol vehicle. Fortunately, we had a cash reserve in place so were able to purchase a sparkling new red 4WD Ute. Some of the funding for this came in the way of donations from our members and local businesses, on behalf of the club I would like to thank all those who contributed. I would also like to thank all our sponsors, partners, members and the community who have donated to the club during the season, the club could not provide the service we do without your help and funding.



Our second season in the club has been a mixed bag; there are still issues with the building which are slowly being addressed by the City of Rockingham Council (CoR). We still have no-one leasing the area down stairs, which is disappointing for everyone. Potential businesses are showing interest in leasing the area, however not all applications have been for a café, we are consulting with CoR in this regard. An issue raised by potential tenants has been the setup costs, which may be significant and impact the profit margin, especially for a café style business.

On a more positive note Fine Tune Fitness is now up and running. We thank Pete and his team for providing a fun, friendly place for our members and the local community to maintain their fitness. The Club kiosk also opened this

season which has been fantastic for our members and the community. I know it has taken a large effort to get this up and running, so thank you to Kim, Robyn, Katherine and the rest of the team for all your efforts this season.

We've another commercial venture currently being trialled, which is commercial training for various first aid and lifesaving courses. Thanks to Carolyn, Joanne and Sarah for taking on this initiative.

Our commitment on the beach this season has been outstanding as always. This includes our beach patrols, Abalone and water safety events. Fortunately the days weren't too hot and overall conditions not too bad. However, there have still been days with many rips and an equal amount of people swimming in those

rips to keep our teams busy. Christmas day was no exception with young Harry Collins doing over a dozen rescues himself, well done Harry. I would like to thank all the patrolling members for their efforts this season. We need your continued support on the beach to make sure our community is safe.

It is great to see the continued growth of our Friday night and Sunday afternoon social events. I hope with some new initiatives we will continue to grow our patronage at the club. Our next challenge is to maintain the momentum during the off-season, stayed tuned for upcoming events. Thanks to Kristie and her team for their efforts this season.

Nippers continues to have a large following with many new children joining our Club. It is

great to see the beach a buzz on Sunday morning, with all the Nippers enjoying themselves and developing their surf awareness. Jess and Bec have done a fantastic job coordinating throughout the season, I would like to thank them, the Age Managers, Water Safety and parents who were down on the beach every Sunday, your efforts are greatly appreciated.

Our competitors have had a great season with many successes at all levels. The Countries Carnival was huge this year with many new competitors taking part from our club. The States Championship provided challenging conditions but Secrets displayed fantastic land and water skills over the 2 days. With the Australian Championships taking place in WA this year we had record numbers attend with everyone putting a

100% effort in for our club. I would like to thank Mark Muir and all the coaches this season for their dedication and commitment, it has certainly reinvigorated surf sports at our club.

As usual we have trained and requalified a staggering amount of awards this year. Megan and her team of trainers and assessors have dedicated many hours of their time to ensure all our members are fully trained and ready for the challenges on the beach. Their efforts cannot be understated and are greatly appreciated.

I would also like to thank the Board of Management (BOM) this year for all their efforts during the season, it's a huge commitment, so a big thankyou to you all. I would also like to thank the office staff for

life saving responsibilities. These are only a few of the projects which have happened behind the scenes by the Board of Management. All of these things are integral for the club to continue to develop and grow, whilst providing the members with the facilities they expect.

Board of Management and sub committees, without their help none of these projects would be possible.

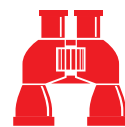

This year has been another successful year on the beach for the lifesaving patrols. This season has seen 34,654 people recorded visiting Secret Harbour beach. We performed 24 rescues and conducted 47 first aids, with 1119 preventative actions recorded.

Pleasingly, a mix of generally good conditions, combined with proactive lifesaving patrols has seen a drop in the number of rescues performed this season. Due to conditions, the majority of rescues were conducted on just a few days, with Christmas day being our busiest.

Our core patrol remained at Secret Harbour beach, with roving patrols undertaken up to the dog beach and down to Golden Bay and Singleton. Again this year the club

provided water safety coverage at Penguin Island and Point Peron during Abalone season. This season we introduced drones as a surveillance tool during regular patrols, with a number of members being trained up.

The club also provided water safety services to a number of community groups including:

- John Calvin School Sports Day
- Rockingham Open Water Swim
- Rotary Beach Side Festival

- Rockingham Youth Beach Party

Overall patrol hours for the year were 5100, with 102 members completing over 24 hours on patrol. This is a great effort by the club, and a significant volunteer contribution to the community.

The season would not be successful without the work of the lifesaving committee and the Patrol Captains and Vice Captains. These people have worked hard to make sure that patrols are

filled, vehicles are fuelled, IRBs are maintained, radios work, and first aid gear is ready. So thank you to the following people:

FINANCE & ADMINISTRATION REPORT

Financial position

The 2017/2018 financial year ending 30th April 2018 saw a positive result with a net profit of \$50,830, up \$44,439 on last year (\$6,391). This is mainly due to over \$166,000 being given in grants and donations, which was used to purchase \$150,884 worth of new assets for the new Surf Lifesaving Club building, including the new signage and a patrol vehicle.

Total revenue for the year was \$647,898, a 35% increase on last year (\$478,222), due to grants received and the opening of the kiosk.

The club ended the year with \$316,720 cash on hand, an increase of \$38,294 on last year (\$278,426) and an excellent result considering how much has been spent completing the new building. The club generated \$150,363 from operating activities, which was mainly from grants received. \$141,794 was spent on investing in to new assets such as the signage and patrol vehicle. The remaining \$29,725 increase related to funding in advance from grants received but not yet spent on a watch tower, wheelchair and solar panels.

FUNDING SOURCES

The club continues to rely on funding from numerous sources, with the main areas being trading (36% up from 35%), grants (18% up from 6%), membership (15%

down from 19%), donations (8% up from 7%), sponsorship (4% down from 11%) and fund raising (1% down from 3%). The club is very grateful for the donations and sponsorship received during the year. To continue to provide services and support our volunteers, we would appreciate and actively encourage others to contact the club, to find out more about how we can help each other to generate the funds needed.

Next year will see the first full year of rent from Fine Tune Fitness. The club is still looking at leasing the space at the bottom of the building but with restrictions in the council lease, the economic environment and the new shopping centres opening locally, it is proving challenging.

FUTURE FUNDS

The Future funds were established for the sole purpose of replacing capital equipment or purchasing new assets within the building, lifesaving, boat and admin sections

of the club. These future funds, however can be redirected at the BoM discretion for the running of the Club and for more pressing priorities.

The Board of Management has not increased the future funds and hence has left the balance at \$158,516. This reflects no incremental increase in cashflows, the amounts spent in the 2017/18 year and amounts already committed for 2018/19 for a new boat and computer equipment in the office, which are both allocated for in the balance. Funds assigned to the Surf Lifesaving section include ~\$10,000 to replace the patrol vehicle. Balance allocation:

- \$98,334 Buildings
- \$32,400 Lifesaving
- \$10,000 Patrol vehicle
- \$22,400 Other
- \$22,282 Boats, boat to be purchased in 18/19
- \$5,500 Admin, computer equipment to be purchased in 18/19



ADMINISTRATION

Despite a slight decline in club membership to 996 in 2017/2018, SHSLSC is still in the Top 10 largest WA Surf Lifesaving clubs. Increasing activity in and around the new building means the operational running and administration of the club is requiring more time, as well as an increased commercial focus

to ensure the club is financially self-sufficient. The club's continued success relies heavily on a Board of Management solely consisting of volunteer members, supported by a small paid part-time team (Accountant Louise Brehaut, Administrator Sharon Phillips, Function Co-ordinator Kristie Nicholas and Member Services Officer Anita Sharpes). More volunteers fill other vital roles such

as Treasurer (Caroline Bates) and Bylaws Officer (Garry Williams). These volunteers will always welcome and need the help from others, in order to bring support, new ideas, skills and experiences. This will enable us to continue providing a unique service to the community.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The Committee have prepared the financial statements on the basis that the Secret Harbour Surf Life Saving Club Inc. is a non-reporting entity because there are no users dependent on general purpose financial statements. The financial statements are therefore special purpose financial statements that have been prepared in order to meet the financial reporting requirements of the members.

The financial report covers Secret Harbour Surf Life Saving Club Inc. as an individual entity. Secret Harbour Surf Life Saving Club Inc. is an association incorporated in Western Australia under the Associations Incorporation Act 2015.

The following is a summary of the material accounting policies adopted by the Association in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Basis of Preparation

The financial statements have been prepared on an accruals basis and are based on historical costs. The accounting policies set out below have been consistently applied to all years presented unless otherwise stated.

Accounting Policies

(a) **Income Tax**

The Association has obtained tax-exempt status under current Australian Taxation legislation.

(b) **Inventories**

Inventories are measured at the lower of cost and net realisable value. Cost is determined by the purchase price of the inventories.

(c) **Property, Plant and Equipment**

Each class of property, plant and equipment is carried at cost less accumulated depreciation and impairment losses (if any).

The carrying amount of plant and equipment is reviewed annually by the committee to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal. The expected net cash flows have been discounted to present values in determining recoverable amounts.

Depreciation

The depreciable amount of motor vehicles and other assets is depreciated on a reducing balance basis.

The depreciation rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed and adjusted, if appropriate, at each balance date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the income statement.

(d) **Cash and Cash Equivalents**

Cash and cash equivalents include cash on hand and cash at banks.

(e) **Revenue**

Revenue from donations and interest revenue are recognised upon receipt of the funds.

Grants received for recurrent expenditures and member's subscriptions are recorded as income in the year in which they are earned.

Revenue from sale of goods (trading income) is recognised when the control of goods is passed to members/customers.

All revenue is stated net of the amount of goods and services tax (GST).

(f) **Goods and Services Tax (GST)**

Revenues, expenses and assets are recognised net of the amount of (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.





INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF THE SECRET HARBOUR SURF LIFE SAVING CLUB INC

Report on the Audit of the Financial Report

Qualified Opinion

We have audited the financial report of Secret Harbour Surf Life Saving Club (the Club), which comprises the statement of financial position as at 30 April 2018, the statement of profit or loss and other comprehensive income, the statement of changes in equity and the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the statement by the Members of the Committee.

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the accompanying financial report presents fairly, in all material respects, the financial position of the Club as at 30 April 2018, and of its financial performance and its cash flows for the year then ended in accordance with Australian Accounting Standards, to the extent described in Note 1, the Associations Incorporation Act 2015 and Division 60 of the Australian Charities and Not-for-Profit Commission Act 2012.

Basis for Qualified Opinion

Cash revenue generated from canteen and fundraising is a significant source of fundraising revenue for the Club. The Club has determined that it is impracticable to establish adequate internal controls over the collection of cash revenues prior to entry into its financial records. Accordingly, as the evidence available to us regarding fundraising revenue from these sources was limited, our audit procedures with respect to cash revenue generated from these sources had to be restricted to the amounts recorded in the financial records. We therefore are unable to express an opinion whether revenue recorded by the Association from these sources are complete and accurate.

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the Club in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110: Code of Ethics for Professional Accountants (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Basis of Accounting

Without further modifying our opinion, we draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared for the purpose of fulfilling the Club's financial reporting responsibilities under the Associations Incorporation Act 2015 and the Australian Charities and Not-for-Profits Commission Act 2012. As a result, the financial report may not be suitable for another purpose.

Responsibilities of the Committee for the Financial Report

The Committee of the Club are responsible for the preparation and fair presentation of the financial report in accordance with the financial reporting requirements of the applicable legislation and for such internal control as the Committee determine is necessary to enable the preparation and fair presentation of a financial report that is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the Committee is responsible for assessing the Club's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless the Committee either intend to liquidate the Club or to cease operations, or has no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

As part of an audit in accordance with Australian Auditing Standards, we exercise professional judgement and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

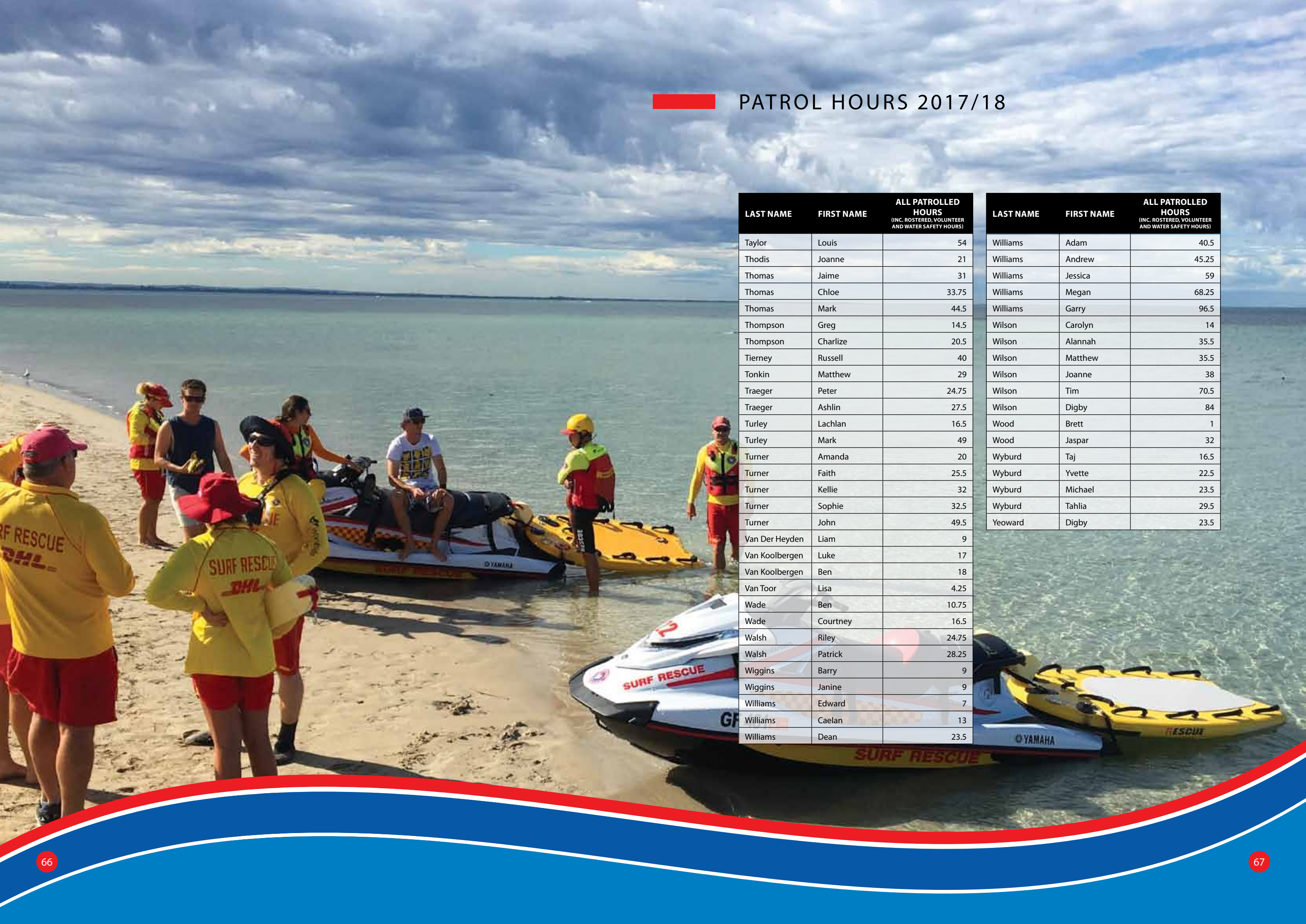
