VICE PRESIDENT'S REPORT



The year has been one of change for the Club. The attitude towards volunteering is changing in society and our Club is not immune to the effects. Membership and participation in our core services

continue to be a challenge and we are still trying to work out what is the best 'fit' for the Club in the new order.

Our membership is reducing. The numbers are down from previous years

primarily in the Nippers group (-29), General (-27) and Active 18+ (-18). Whilst the last effects of Covid and the current economic climate are having an impact, there are more underlying issues we need to deal with; and

the Board has recognised this as a problem. The answers are not simple and easily rectifiable.

In my last report I highlighted the change over from Jane to Karen as

Office Manager. Karen has taken to role with a pace that I wasn't expecting and has voluntarily taken on much of the sponsorship tasks that the Board were previously managing. We, like many organisations, lost a

lot of our sponsorship during Covid and we were fortunate that we were supported during this time financially by Government and surf lifesaving payments. In a post-Covid world these payments have now gone, and





we need to go back to supporting ourselves and Karen has made sure the increased sponsorship is helping with this support.

Karen has also been working in the background on bringing our accounts up to date. The Club's accounts have evolved over time and the changes in the Club structure have not been reflected in the accounts at a detailed level. Karen has been working with Max and myself to bring these into line so we can understand our income, budgets and expenditures at the micro level. This initiative will help our members understand at the working level their respective budgets for the year.

Kim continues to manage the Club functions and adds many hours in the background to making that side of the Club operations work effectively. Kim also continues to provide the members with advice and assistance as required with many compliments on the pleasant way she goes about providing help wherever it is needed.

The café is now in operation, and I see many of our members enjoying themselves on the weekend either outside in the sun or inside in the comfortable surrounds. We are still working through the complexities of being a landlord within a Council owned building, but it is generally settling down to a good working relationship with the tenants.

The Member Space is continuing to progress. Detailed plans and specifications have now been developed and as I write this report the Quantity Surveyor that the Club has engaged is developing the cost schedule and this will be presented at the upcoming Annual General Meeting. The development application criteria set by Rockingham Council continues to require a lot of volunteer resources within the Club and none of it is easy.

From the last AGM a request was made by our members for reforming the Club's voting rights. The Board called for a committee to be formed to review the Club's current Constitution and their report was presented earlier this year. The Board agreed with one of their options that voting rights be given to any financial member within the Club that completes at least 16 hours of service to the Club, and this is independent of operational lifesaving requirements. The aim is to open the voting to any member that contributes a reasonable amount of service to the Club and thereby remove the 'second class citizen' stigma of restricting the Club voting rights. It takes a considerable amount of time to get a change like this through the various organisations that require input. We have had considerable assistance from the legal section of SLSWA and we feel we are very close to a final draft that can then be sent to the various state government areas for their reviews before being presented at a Special General Meeting later this year.

The Clubs finances are in good shape with the renegotiation of the gym lease and start of the café lease. Combined with an increase in sponsorship, a conclusion could be made that the Club has a considerable surplus in funds. The reality is that we need to pay for the Club Ute we purchased recently as well as the sundeck upgrade. Combine these two major expenses with a falling revenue base from reducing member numbers as well as considerable increases in Club running costs, the picture is more towards a neutral financial state. As I highlighted above, the attitude to volunteering is changing and we now struggle to get tasks that were previously carried out free by volunteers, are now completed by casual employees and this is a further drain on our financial resources. The Board has the unenviable task of managing the Club's finances across all portfolios and this sometimes requires bad news to be handed out to balance the books evenly and fairly.

This is my last year on the Board. After two years as Director of Lifesaving and two years as Vice President I feel it is time for me to give someone else an opportunity. I will still be around the Club after this, so I hope to see many of you next season. See you on the beach.

LIFESAVING REPORT

From a lifesaving perspective, the 2023/24 season has been good. Our members donated 5,620 hours of their time on our home beach, at a multitude of water safety events, carnivals and abalone patrols. This is the second highest number of hours recorded in the last 10 seasons, and in a time where cost of living has increased significantly it is honestly amazing that we have continued to engage our members and their valuable time.

I would like to acknowledge the 3 members who this season spent over 100 hours patrolling our beach, Rhett Gibbons, Stig Kalande and Villiam Kalmar. A shout out to Jazmin Kalmar who was just shy at 99 hours this season. Your commitment to our Club and the safety of the Secret Harbour beachgoers does not go unnoticed.

In a further breakdown of the hours, we had 186 members contribute to the total hours of both Patrol and Water safety. The Crusaders (Under 14's to Under 19's age group) represented 72 {39%} of patrolling members this season who did 2463 (45%) hours. There were 29 {15%} young adults in the 18-25 age group this season, and they contributed 980 (18%) of our hours.

The Club has 37 Long Service/Life Members who due to their previous

outstanding commitment to the Club are exempt from the need to complete patrol hours to maintain active membership. Of them, 18 {9%} have continued to contribute a total of 517 (9%) hours this season. That leaves the remaining 67 {36%} adult members who contributed 1563 (28%) of our total hours this season, of them only 30 members patrolled between the flags.

This highlights a major problem within our Club, that we are dependent on our youth to fulfil our core focus as a Club. While we do Nippers, External Water Safety Events, Functions and Surf Sports they are all to support our mission to save lives at our beach. This season, almost all Crusaders and Long Service/Life Members who did Water Safety hours completed Patrol Hours. However only 44% of Adult members did the same, a major deficit. In the last 3 seasons the Club has trained only 15 new adult Bronze Medallion holders, of which 11 remain active within the Club. There will be a focus from the Club to engage more adult members to ease the burden on our Youth and Life/Long Service members however the effort needs to

come from the members as well. The Club would gladly appreciate anyone who would recommend lifesaving as a volunteering opportunity to any of your friends/family, or even your fellow Nipper parents. Our Club currently offers Nipper parents the opportunity to complete their SRCs/BNZs with their children through the Crusaders Program.

In addition to our 48 rostered patrols, 7 Public Holidays and Nippers, Secret Harbour has supported numerous additional events/carnivals. As always we have continued to support the 4 Abalone sessions in the area, at Penguin Island and Point Peron. This season there were some kinks due to the weather, leaving Penguin Island closed for one session and the whole session being called off on another day. Thank you to Garry Williams who has continued to coordinate these sessions for the Club. Secret Harbour also hosted 3 carnivals this season, as well as sending personnel and assets to provide Water Safety at an

additional 3 carnivals. Furthermore, we have supported 8 Water Safety events within the Rockingham Area. This totals up to 74 days of Patrol of Water Safety this season, a number that pushed the Club to its limits on what we could support. I would like to thank Mark Thomas who spent multiple afternoons/evenings chasing up volunteers, along with everyone who did time supporting these events, there are too many of you to name.

Our beach attendance this season was an increase on previous seasons, up to 62,133 people which almost beats our current record (since 2016/17) of 62,378 people in the 2018/19 season. Some potential explanations of this are the overall calmer water conditions and warmer/drier weather this season. Another factor that likely played into the increased numbers is the opening of our new Cafe and the crowd that it has drawn. As usual we saw the change in wind direction in the last two or so hours of patrol turning away all but the most hardcore beachgoers.

We have seen a dramatic increase in preventative actions this season, up to 3,138 actions (compared to the previous record of 1,119 in 2017/18), likely explained by the increased pressure from myself and my Patrol Officer Jasmine for accurate record keeping of everything we do. I expect this number to continue to increase as

more education is spread about what exactly a preventative action is. As a brief explanation, a Preventative Action is any action that could prevent a rescue or first aid, such as a discussion with a member of the public about where the best place to swim is, or sending the ATV/IRB to do a rove north or south. Going forward a more thorough guideline of what could be classed as a preventative action will be developed for all to see.

Rescues were up this season compared to the last two, sitting at 43 total. However, looking at the number on a per 1000 attendees basis we are equal to our record low since 2016/17. This season 70% of our rescues were effected by Powercraft, which shows how important our operators are. We had a big focus this season on keeping our craft active on the water instead of on the shore.

An initiative spearheaded by Jasmine was the introduction of the second patrol boat which as part of its duties covered both Surf Sports and Nippers as well as being utilised to cover patrol on the extra busy days. It also provided an opportunity for more of our new IRB Drivers and Crew to have time in the boat to develop their skills. The feedback we received was overall positive, and we are planning to utilise this strategy next season with some changes.

RESCUES

From a First Aid perspective, we recorded 133 individual instances, an increase on previous years. Again, this can likely be attributed to our push for more accurate recording as an 82 of those were minor stings and a further 18 were minor cuts. Moving towards the more major incidents, we did unfortunately have 2 spinals and 2 near drownings this season. Thank you to the teams involved in those incidents and the effort they put in to ensure the best possible outcomes.

This season our Emergency Response Team continued their good work, responding to a number of incidents. We expanded the team from 3 members up to 8 which improves the Clubs ability to respond across the Peel Region. If you think you might be interested in joining please email me and I will review.

Over the 2023/24 season, Secret Harbour has invested in our youth to promote them into more senior positions within our patrols. Eight of the fifteen

members of the Patrol Leadership Group (Captains/Vice-Captains) are between the ages of 18 and 23 years old. This is a big change compared to previous years and a step in the direction of continuity, allowing our older members to step back into mentorship roles and hopefully increase retention across both the young leaders and older mentors.

We also were fortunate to be the last Club able to access SLSWAs Drone

Program this season. Thank you to SLSWA who purchased 2 new Mavic 3 Drones with all the fancy kit that comes with them. Our Drone Officers Joe and Nick have spent quite a bit of time preparing the drones and ensuring all of the governance is in place. SLSWA have also already provided the training for Joe to be a facilitator and there is another session soon for Nick to complete his trainer training. Over the off season they will be working to get 4-8 new Drone Operators ready for next season. If you are interested in this course, please submit an expression of interest to the Club office.

Lastly, I would like to thank everyone who has helped me over the season.

Being new into this level of management it was a bit of a running start heading into the season, thanks to Karen and Kim in the office for teaching me a lot about how money and the Club works.

Thank you to my Patrol Officer Jasmine who has been my right hand woman this season, making sure everything to do with patrols was sorted as best as possible. And thank you to all the Patrol Captains, Vice Captains, Water Safety Coordinators; without them Patrols would not have been able to happen.

In saying that, thank you to Graham Shackles who stepped up and learnt on the fly how to be a Patrol Captain for 4

of our 7 Public Holiday Patrols, and the collective of Mark Glover, Riley Walsh, Karen Alsop, Emily Buckley and Meagan Tong who worked together to manage another of our Public Holiday Patrols.

Without them those patrols (which are part of our agreement with the Council) would not have been able to go ahead. And finally thank you to the rest of the Lifesaving Committee, these are the people who make sure you have a stocked First Aid Room and working Powercraft, they put in a lot of time and effort behind the scenes each and every year.

FINANCIAL REPORT



This is my last year as a director and I would like to take the opportunity to thank Karen and Kim for keeping the books of the Club, my fellow directors and all the members and staff at the Club who have helped and supported me throughout the duration of my time as a director.

In terms of financial results, if you look at Note 2 in the Club's accounts you will see that our "year on year" cash position has improved, and the Profit and Loss shows a profit. This improvement is due to the Club leasing its commercial space to the café and carefully managing its costs. If we were to remove the Café income from our finances, then the Club would be close to making a cash loss. So, the Club is still reliant on the kindness of other organisations in the form of grants and donations, and we are still some way away from achieving our strategic objective of ensuring the long term financial viability of the Club. During the year the board made the expensive decision to purchase a ute and use the Cafe rental income to fund the development of the upper deck Club member space. Currently we are in the final stages of having the member space plans Council approved, we'll hear more about this in the future.



The Club member space will require a significant part of the Clubs' available reserves, so the Club has about the same funds available to members this year when compared to last year.

Regrettably there is no sugar on the table, and the Board will need to

continue it's careful management of Club finances.

I will continue to be involved with the Club and look forward to seeing everyone on the beach.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The Committee have prepared the financial statements on the basis that the Secret Harbour Surf Life Saving Club Inc. is a non-reporting entity because there are no users dependent on general purpose financial statements. The financial statements are therefore special purpose financial statements that have been prepared in order to meet the financial reporting requirements of the members.

The financial report covers Secret Harbour Surf Life Saving Club Inc. as an individual entity. Secret Harbour Surf Life Saving Club Inc. is an association incorporated in Western Australia under the Associations Incorporation Act 2015. The financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB'), as appropriate for not-for-profit oriented entities under the Australian Charities and Not-for-Profits Commission Act 2012 and the Associations Incorporations Act 2015.

The following is a summary of the material accounting policies adopted by the Association in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Basis of Preparation

The financial statements have been prepared on an accruals basis and are based on historical costs. The accounting policies set out below have been consistently applied to all years presented unless otherwise stated.

Accounting Policies

- (a) **Income Tax**
The Association has obtained tax-exempt status under current Australian Taxation legislation.
- (b) **Inventories**
Inventories are measured at the lower of cost and net realisable value. Cost is determined by the purchase price of the inventories.
- (c) **Property, Plant and Equipment**
Each class of property, plant and equipment is carried at cost less accumulated depreciation and impairment losses (if any).

The carrying amount of plant and equipment is reviewed annually by the committee to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal. The expected net cash flows have been discounted to present values in determining recoverable amounts.

NOTE 1: STATEMENT OF ACCOUNTING POLICIES (CONT'D)

(c) Property, Plant and Equipment (CONT'D)

Depreciation

The depreciable amount of motor vehicles and other assets is depreciated on a reducing balance basis.

The depreciation rates used for each class of depreciable assets are:

Class of Fixed Asset	Depreciation Rate
First aid room equipment	10% to 20%
Merchandise and Office equipment	10% to 100%
Rescue, Training and Comp equipment	10% to 100%
Social hall, bar and canteen	10% to 100%
Building	10% to 100%

The assets' residual values and useful lives are reviewed and adjusted, if appropriate, at each balance date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the income statement.

- (d) **Cash and Cash Equivalents**
Cash and cash equivalents include cash on hand and cash at banks.

- (e) **Revenue**
Revenue from donations and Interest revenue are recognised upon receipt of the funds.

Grants received for recurrent expenditures and member's subscriptions are recorded as income in the year in which they are earned.

Revenue from sale of goods (trading income) is recognised when the control of goods is passed to members/customers.

All revenue is stated net of the amount of goods and services tax (GST).

(f) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.



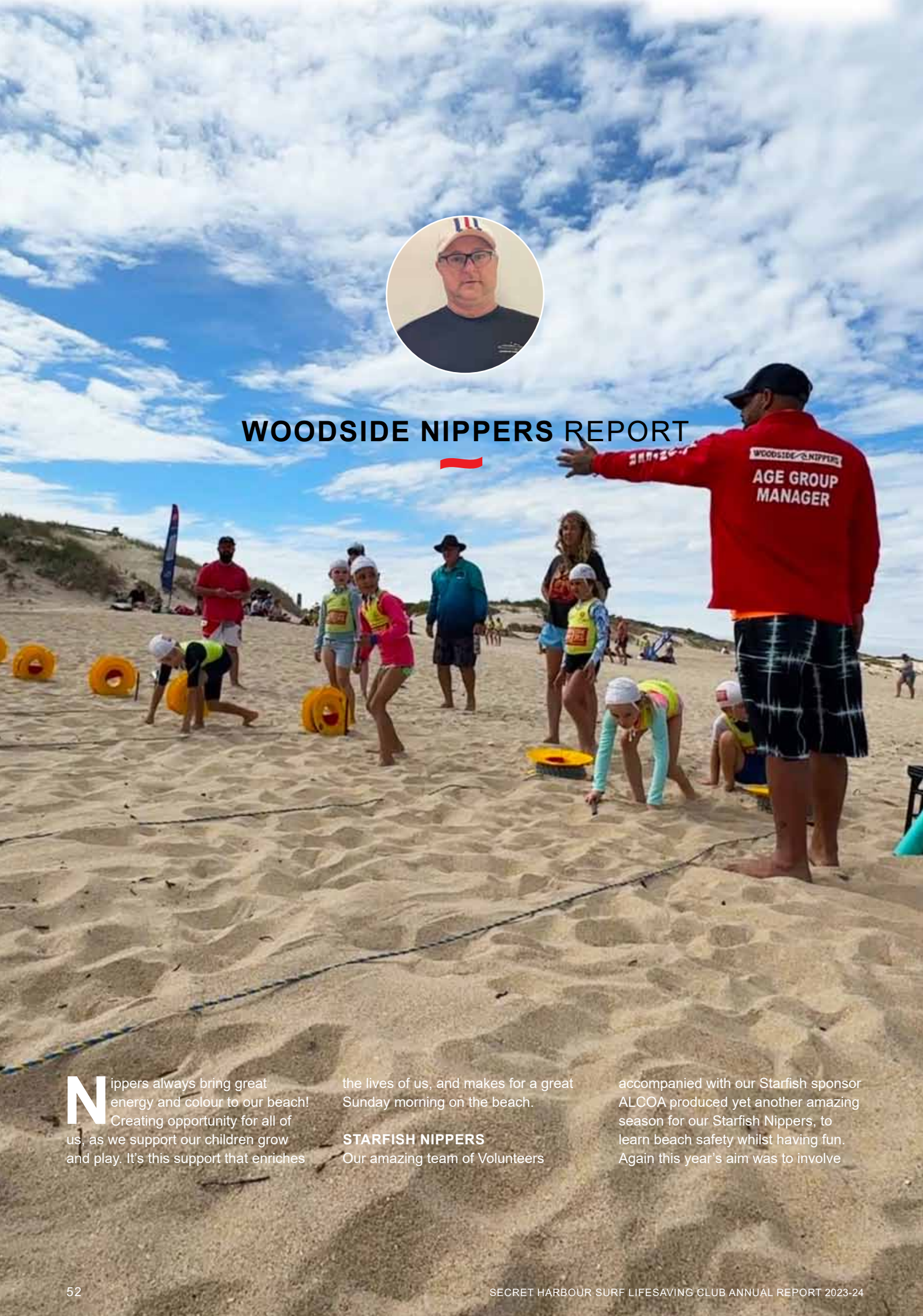

NIPPERS

I had a simple goal, how to make a 6 year old want to wear the Yellow and Red Uniform of a lifesaver and be a contributing member of our Lifesaving Family.

The 2023/24 season started a little differently, with the first day being at Rockingham Foreshore where we conducted our swim proficiencies. The opportunity provided the perfect stage to sell our sport, with our Nippers being the stars of the show. Benign conditions this year provided unique opportunities for our Nippers to experience 'Rips' in a controlled scenario, as well as giving our Nippers the opportunity to gain confidence on the use of lifesaving equipment such as the board.

Secret Harbour Nippers competed in numerous levels of competition, from the Secret Harbour Championships,



Secret Harbour Gold and State qualifiers. Secret Harbours little nippers were well represented in the local Little Nipper competition; and as always did themselves and our Club proud. We look forward to seeing these little champions representing our Club in the future.

This season we introduced Pool Rescue for our 10s, 11s, 12s and 13s. Big thanks to HMAS Stirling allowing access to their facilities. We had in excess of 130 Nippers and Parents attend this event and already we are seeing increases in the Pool Rescue attendees.

Whether it be swimming to the cans for the first time or the smile of their faces when they catch their first wave, all our Nippers have accomplished great things this year and each and every

one should be proud of what they have accomplished.

As we watch our kids progress through the years of Nippers culminating in the under 14's achieving their Surf Rescue Certificate, it's a credit to all involved as we as a Club continue to nurture our amazing Nippers, resulting in some amazing young people whose potential is endless.

U13 Crusader Experience – The Under 13 season was conducted a little differently for the 23/24 season, with the first 6 weeks the primary focus was that of the Woodside Nipper Program. The remainder of the season we introduced skills and introduced the proficiencies needed to accomplish their Surf Rescue Certificate at the beginning of the 24/25 Season. The change in instruction was to introduce

the skills experienced whilst doing their SRC; and set expectations as our U13s move into the ranks of the Crusader cohort and begin their Lifesaving Journey.

VOLUNTEERS

Age Managers – Nippers is nothing without volunteer Age Managers, they bring so much to our Nippers experience. Together they achieve Safety and Surf Lifesaving skills, the enthusiasm and exuberance and commitment to their age groups; ensuring that our Nippers not only meet their goals but thrive. Each year we recognise one Age Manager for their contributions, without a doubt this has been the hardest job within the Youth portfolio. All our Age Managers sacrifice much of their time with little to no thanks, and each year they continue to turn up with enthusiasm and what

Many of you have realised this course is not particularly hard but is an essential component of getting our children in the water. We must achieve Five

Nippers per One Water-Safety or One on One with our Starfish Nippers. This is a big commitment on our resources but an essential one, and our NRC parents have certainly stepped up to the plate this year. Thank you to you all for this thankless and essential part of our Nipper Safety and Success.

Behind the Scenes – Much of what happens on a Sunday goes unnoticed and behind the scenes.

The amazing staff in our Office ensure that everything is ready to go, advertising, announcements etc. but more importantly they keep me on track and focused. Our Club Captain, ever present on our Nipper Days, making himself available to all, and then the lovely ladies who work our Kiosk, providing sausages and drinks to our Nippers. All these volunteers complete thankless jobs behind the scenes ensuring that our Sundays run

CRUSADERS CORNER

Well - it's been another big year for the Crusaders! It's now 11 years that we have had the Crusaders and what a journey it has been! You guys and girls have been absolutely Awesome in your support to the Club. The numbers of 13-25s involved in our Club based Youth Engagement Program (YEPs) continues to flourish.

This season our stats are again impressive with the expansion three seasons ago of our program to include the 18-25; all of which have grown up in the Crusaders program. These guys now also make up the bulk of our Crusader Facilitators – which is absolutely AWESOME!

The Youth this season again contributed significantly to the operations of the club assisting with Water Safety, Patrols, Abalone, Community Events and Nippers just to name a few.

They contributed some 3597.46 (up from 3254.15 last season) of total Club members contribution of 5823.46 hrs in Patrol/Abalone and water safety support (includes Nipper water safety).

I have changed the reporting a little from last season so we can better measure our progress in that age group.

The breakdown for Season 2023-24 is as follows:

13-15 year olds – we had 43 (up from 41 last season) complete 1417.95 hrs (that's up from 1349.59 hrs last season. (on average that's an impressive 32.97 hrs each)

16-17 year olds – we had 28 complete 1043 hrs (that's an impressive 37.25hrs each)

These 71 youth members collectively completed 2460.95 on Patrol or water safety. Noting our 13-17s are completing 42% of the Clubs patrol obligations.





18-25 year olds – we had 35 complete 1121.25hrs; which is an impressive 32 hrs each on average.

An exciting factor to note is that within this group only 11 patrolled 3 seasons ago; we have had a significant growth of in 3 years! Another exciting factor is this group is becoming our next generation of Trainers, Mentors, Facilitators, Patrol Vice and Patrol Captains; and Board Members.

Hopefully we are moving forward with the retention of our U17s as they move to the U18-25 age groups. Our challenge is to continue to work with the team so that we can continue to engage and ultimately keep them.

The Crusaders commitment again this season has been outstanding. We had 3 Crusaders all patrol over 100 hrs

(Rhett Gibbons 105, Villi Kalmar 104.92 and Stig Kalmar 102.42) wow! We had 3 over 80 hrs (Jazmin Kalmar 99, Bella Wise 91.5 and Mitchell Shackles 83.5

We had 5 over 60 hrs (Iona Alsop 69.42, Zara Hobson 62.67, Joseph Tyrrell 61.5 and Jacob McCarron 60.6). We had 5 over 50 hrs (Marcus Quinn 59.5, Mikaela Cook 58.92, Megan Tong 56.75, Jordon Morton 53.75 and Angus Belton 50.5) The remaining 54 provided 25 hrs of patrol/volunteer or water safety service. Well done team!

A number of the Crusaders are Age Managers, Assistant Managers, Office Bearers of the Club, Directors (Mitchell Shackles our Director of Lifesaving for the Season), and new Trainers. Many are mentors to the younger Nippers and to their peers. Some have competed at the highest-level

competition and some have been acknowledged as evolving leaders; such as our 2 Junior Club Captains in Jazmin Kalmar and Jacob McCarron and our 2 Vice Captains in Jasmine Noorman and Izac Geddes

Of note is that Mitchell Shackles attended the SLISA National Leadership College which is for 20-30 year old emerging leaders. What an honour and well done Mitchell. Mitchell now joins a few from the Club that have attended the National Leadership College including Izac Geddes, Jessica Williams, and Alannah Maurice.

3 Crusaders attended the Rise Up Camp: Carris Terri, Villiam Kalmar, and Abbi Venn.

3 Crusaders attended the Rookie Lifeguard Program: Rebecca Febia, Jazmin Kalmar, and Bella Wise.

We also have some nominees and Finalists in this year's Youth Awards of excellence in Carris Terri – SH Youth Achiever of the Year and Finalist for the WA Youth of the Year, Stig Kalande was a nominee for U15 Lifesaver of the Year and Finalist for the WA U14/15 Lifesaver of the Year - Outstanding!

We also kicked off an IRB Drivers course over the winter at the dam with an over nighter and then of course it was back into our IRB/ RWC famils, IRB Awards. We held a number of exercises with Marine Rescue Rockingham, completed our SRC/BNZ/IRBC Crew development Program that finished with the SRC/ Bronze Camp sleepover, conducted Abalone Patrols, Rock Rescue Famils off Secret Harbour Beach with our U13s. We had a Powercraft famils at Denmark, Pengo's and Point Peron. We also had our RWC members in Denmark back in May. The annual Feb camp was of course at the new



SLSWA Centre of Excellence at Margaret River. With 53 attending this season, I'm sure all would agree that the facility was awesome and the integration of an advanced lifesaving experience with Bunbury, Busselton, Smiths Beach and Margaret River SLSC was great.

Our Crusaders had an outstanding year in Surf Sports across all disciplines including Surf Boats and Pool Rescue; which is awesome. Surf Sports is an area that we need to build as a Club as all of the research shows that members involved with Surfsports or a program are retained for much longer within the movement.

I'm sure if you go to the surf sports results section of the annual report you will all agree that we have been extremely well represented this season by competitors with outstanding results in Pool Rescue, at both Country and State levels.

We have qualified 10 youth age managers and age managers assistants.

This year we had 17 Crusaders progress their BNZ, 20 their SRCs and 12 Crewies. Huge effort team! We also qualified another 9 Crusader IRBDs; Aiden Ayoub, Oliver Ayoub, Toby Carus, Matilda Hamer, Jazmin Kalmar, Jacob McCarron, Meagan Tong, Ruby Moogan. We still have 4 to finish off over the winter. We also qualified 3 25+ IRBDs as apart of the winter IRBD training – that's significant as it gave the Club 11 new drivers for the 23/24 season. For our older Crusaders we had 1 complete their WA Trainers Award in Jasmine Tong. We will also progress 3 new BNZ trainers from our Mentors – Paul Johnson, David McCarron and Tim Wilson along with one New IRBD Trainer in Patrick Walsh.

We also qualified another 3 RWC

Crusader operators in Nic Graydon, Riley Walsh and Tayla Jones at the very end of last season.

19 Youth Engagement Program Gold Award.

Now these guys have done the extra yards being part of a community program – which means they have been part of the Abalone Patrols, starfish nippers or taken on the role as an age manager to achieve this reward this season.

This year we formally established our Crusaders Committee with a budget, a Terms of Reference and within the committee have appointed a Chair; being Mitchell Summers from the Crusaders Group. The Committee is meeting monthly and working on a

number of initiatives that we will share over the winter months.

We embarked on an 18-23s program 3 seasons ago and now it has cemented itself as an 18 to 25s group; with the group growing from 11 to 35 active (that is patrolling or providing other service). While we didn't do much as a group, this small group has done lots in reflection mainly in the Powercraft areas of upskilling; and in advance skills this group has provided significant support to the club as a whole.

We have our 18-25s camp over the weekend 24-26 May at the SLSWA Facility and some other winter activities with the 17s down south and in kicking off the delivery of the Silver Medallion Advance Lifesaving Course in the Peel area for our 16 year olds and above. Don't worry there will be activities going on for our U14/U15s as well.

I'm excited to work with these young

men and women and to explore their potential and growth as our Lifesavers of today and leaders of tomorrow.

I hope to see you all over the winter as the team plans our next adventures – Logue Brook Dam, Capel working with Peel Clubs and SW Clubs, Advance Lifesaving Courses, Stirling Pool and Marine Rescue adventure...and our Powercraft courses.

Firstly, our Crusaders – you guys rock!

To the mentors that assisted with the camp, our monthly outings and Sunday morning activities –there are just too many of you to mention now which is part of the success of the program. To the ladies that assisted with feeding some 70 people at our Club sleep over to those that assisted with transport - we salute you guys.

Our Crusaders leadership – LEGENDS! There are many others

that have assisted along the journey this season and I thank you guys HEAPS!

There is nothing better than watching and being a part of the development of these fine examples of our Western Australian Youth and our leaders of the future.

Our Sponsors, Paul Papalia, Team Anzac, Alcoa have assisted us in financing our program and Megan Williams for the Gold rewards.

And who can forget the Mandurah SES for loan of their Bus...Thank you!

Finally, we'd like to acknowledge the BoMs support of the program. The program is a substantial investment into our future.
